The Presbytery adjourned at 9:00 p.m., to meet 8:30 a.m. August 14. Motion by David Williams which received a second. Closing prayer by Rev. Michael Bolus

The Presbytery Reconvened at 8:30 a.m., August U., 1976.

Call to Order --

Moderator Rev. Charles McNutt

Opened with prayer by the Stated Clerk, and also a season of prayer by delegates in attendance.

Communication --

The following requests by delegates to be excused from the Presbytery were granted: Rev. William E. Hill, Jr., James Brown (Pliny)

Dismissal --

A motion by Rev. William Fitzhenry to dismiss Candidate James F. Miller to Vanguard Presbytery was seconded and passed.

Introduced at this time were: Elder Allison McDaniel, South Ruffner; Dan Toney, Faith; and Women In the Church.

Examination of Candidates for the Ministry --

Committee on Examination of Ministers and Candidates recommends that John Batusic be examined as candidate for the ministry at this time.

Rev. William Fitzhenry conducting the examination found John Batusic's credentials in order.

Experimental religion -- approved

Motives for seeking the ministry -- approved

Rev. David Williams moved that the examination be sustained as a whole, received a second and passed.

Constitutional questions asked by the Moderator.

Charge given by Moderator Charles McNutt, reading from I Timothy 4:6-7-8, Acts 4:13

Prayer by Rev. William Fitzhenry

John Batusic was received under care of Presbytery and given right hand of fellowship.

Examination of George B. Alder, II for licensure --

His transfer as a Candidate was received from Westminster Presbytery. Credentials found in order.

Reports on written parts of trial were approved and sustained.

The Presbytery instructs its Committee on Examination of Ministers and Candidates to follow the procedure for examination to licensure from B.O.C. 20-6.

Rev. William Fitzhenry conducted the examination.

1. Christian experience and testimony be sustained.

2. The examination in theology be sustained.

3. The examination in English Bible be sustained.

. The examination in the sacrements be sustained.

5. The examination in Church Government be sustained.

A motion was made (which received a second) that the examination as a whole be sustained and that the Presbytery proceed to licensure. Motion passed.

Moderator Charles McNutt propounded questions from the B.C.O. (Book of Church Order) for licensure and closed with prayer.

Therefore, at Rebecca Littlepage Church, the 14th day of August, the Presbytery of New River, having received testimonials commending George B. Alder, II, and evidence of his being a communicant of the Church, of his good moral character, and of his having pursued suitable course of study, proceeded to submit him to the prescribed tests for licensure, which were met to the approval of the Presbytery on his satisfactorily answering the questions appointed to be put to applicants for licensure.

George B. Alder, II was licensed by the Presbytery to preach the Gospel within the bounds of this Presbytery, or wherever he in an orderly way shall be invited to preach.

He accepted the call pending ordination by Presbytery at a later meeting.

The right hand of fellowship was extended by all in attendance.

Introduction of Overtures --

Rev. Linwood Wilkes read the following overture (with amendments):

OVERTURE TO THE FOURTH STATED GENERAL ASSEMBLY BY THE

NEW RIVER PRESBYTERY

Whereas, all Christian Churches have but one major job description and we call it the Great Commission, and

Whereas, many of our churches can testify that only through self-denying work in evangelism from their own door to the ends of the world, have they received great blessings.

Therefore, be it resolved that New River Presbytery overtures the General Assembly meeting in Greenville, South Carolina, to appoint a committee to study our present priorities and report its finding to the General Assembly.

And further, that the General Assembly instruct the Committee to seek a percentage base for the 1977 budget of undesignated funds, other than the

35% for World Mission, 35% for Christian Education, 20% for Missions to the United States, and 10% for Administration, proposed in the Administration Committee Report.

Whereas, we would recommend to the General Assembly the continuence of a policy which would closely approximate 40% for Missions to the World, 30% for Missions to the United States, 20% for Christian Education, and 10% for Administration.

A motion by Rev. David L. Williams that we accept the overature as amended and present it to the Fourth General Assembly. A second to the motion by Rev. Michael Bolus. Motion carried.
