CALLED MEETING NEW RIVER PRESBYTERY PRESBYTERIAN CHURCH IN AMERICA April 12, 1980

Friendship Presbyterian Church, Princeton, WV

The meeting was opened at 3:00 P.M. by prayer with Rev. Michael Bolus, moderator, presiding.

Teaching elders present were Norman Evans, Linwood Wilkes, John Dodd, James Fishel, Rod Mays, George Alder II, and the moderator.

Ruling elders present were Douglas Dority (Westminster), Tom Minter (Lebanon), Charles Kennedy (Little River), Ralph Harris (Kanawha Salines), and Forrest Rumberg (Friendship).

Presbytery proceeded to examine Rev. Ronald Parrish of Evangel Presbytery who has been called by Martinsville Mission to serve as organizing pastor. Rev. Evans assumed the moderator's office while Rev. Bolus conducted the examination on experiential religion. His motion to sustain that portion of the examination was seconded and carried.

Rev. Bolus also conducted the examination on theology which was sustained following his motion.

Rev. George Alder conducted the examination on the sacraments. His motion that this portion of the examination be sustained was approved.

Rev. Rod Mays conducted the examination on church government. His motion that this portion of the examination be sustained was approved.

Rev. Mays moved that the examination as a whole be sustained. Seconded and carried. Rev. Parrish was then accepted as a member of New River Presbytery pending his dismissal from Evangel Presbytery.

The moderator read the call from Martinsville Mission to Rev. Parrish. The call was then placed in the hands of Rev. Parrish. He was then given the right hand of fellowship by members of Presbytery, following which he signed the ex-animo statement.

Presbytery adjourned with prayer by Rev. Dodd at 3:45. A time of fellowship followed with refreshments served by the ladies of the host church.
