CALLED MEETING

NEW RIVER PRESBYTERY

The Called Meeting of Presbytery was convened at 10:30 am with prayer by Rev. Charles McNutt. In the absence of the moderator Rev. McNutt called the meeting to order.

A motion was made and carried that Rev. Charles McNutt moderate this meeting of Presbytery.

It was noted there were visitors present and they were introduced by Rev. Mays. They are Mrs. Virgil Roberts, Mr. Bob Esler, and Rev. Donald Hite Post, Jr.

The moderator stated the call for this meeting was in accordance with the requirements in the BCO and the purpose of the meeting was as follows:

"1. To grant a transfer for Rev. Ron Parrish from this Presbytery to the North Georgia Presbytery of the PCA, to pastor the Chestnut Mtn. PCA.

2. To examine and receive Rev. Donald Hite Post, Jr. from the Calvary Presbytery of the PCA, to be associate pastor of Covenant PCA, with responsibility in ministry to the Huntington Mission.

A motion was made and carried this call was in order, and to proceed with business.

Item #2 was taken first and a motion was made and carried that Rev. Donald Post, Jr. would be examined and received pending receipt of transfer from the Calvary Presbytery.

in Church Polity, by Norman Evans - Motion to sustain,

Carried.

A motion was made and carried that the examination as a whole be sustained. The Call was then read and approved and presented to the Pastor Elect after motion to do so was moved and carried. Rev. Post accepted the Call and was enrolled after signing the Ex Animo statement.

A motion was made and carried that the following Commission of this Presbytery be named to install Rev. Post, with the date of installation

to be set later. Commission will be: Rev. Mays (Convenor), Rev. McNutt, Rev. Evans, Ruling Elder V. Roberts, Ruling Elder R. Burke, Ruling Elder D. Post, Sr., and Ruling Elder R. Kresge.

The installation service will be held in Huntington.

Item #1 on the docket was then taken up. A letter was read from Rev. Ron Parrish and a motion was then made and carried that a transfer be sent for him to the North Georgia Presbytery of the PCA.

The business of this meeting being concluded a motion was made and carried at 12:25 that Presbytery adjourn. The meeting was then closed with prayer by Rev. Post.
